## ANIMAL AGREEMENT CONTRACT

Purchaser is responsible for checking with his/her state, county, and municipal rules and regulations concerning ownership of exotic animals in the state in which the animal will reside. Junglespots assumes no liability or responsibility for legal actions resulting from the purchase of an exotic animal where they are prohibited.

If at any time the purchaser is unable to retain ownership, the seller reserves the first option to take the animal back into his/her ownership accompanied with a health certificate, medical and history papers and showing good health. No refund will be given unless there is written proof given by a licensed veterinarian that there was a congenital or hereditary disorder. The seller reserves the right to have his/her own veterinarian review the results of the written proof and decide whether it is a congenital or hereditary disorder. Shipping or other fees involved in this process are the responsibility of the purchaser. If it is decided there is a congenital or hereditary disorder, an agreeable refund will be decided between the purchaser and seller at the seller's discretion.

There will be a 24-hour guarantee on all animals purchased from Junglespots. You may take your animal to your veterinarian within 24 hours (unless a weekend or holiday interrupts the 24 hours) from the day you receive the animal to have it checked. If any illness or infection is found, the seller agrees to cover this vet expense with receipts. Your office visit, exam, or any vet charges on a HEALTHY animal will be the responsibility of the purchaser. To the best of the seller's knowledge, at the time of sale, the animal has no illnesses, defects, and is free of viruses.

Deposits are accepted to hold any animal being purchased from Junglespots. You will have 24 hours after it is received for a full refund. After 24 hours it will not be refundable since the animal had been taken off the market at your request and would then have the expense of being re-advertised.

Full payment must be received, unless otherwise agreed upon between seller and purchaser, before any delivery will be made. Purchase price includes animal and current vaccines and wormings. Shipping costs are separate and are the responsibility of the purchaser. Shipping costs include health certificate, carrier and flight. Any payments made through Paypal are subject to a 3% additional charge on the TOTAL purchase price (including shipping) for the use of this option of payment.

It should be taken into great consideration the time and commitment involved in the purchase of any new animal. Here at Junglespots, a great deal of time is spent trying to

provide the best of care to each and every animal here. They are extremely socialized with other animals, kids and people in general. Each animal is hand-raised and given a great deal of love. In return, we ask that the same is done when the animal leaves here. We, of course, cannot be held responsible for how an animal may act in its new environment. This is new territory for the animal. It is the purchaser's responsibility to love, be patient, and teach the animal to behave as you desire.

This agreement is made for the mutual benefit of the purchaser and seller, but most importantly, to protect the animal.
